Notes

Change of name or address of the applicant or proprietor

Other changes

For applications:

If you want to correct or change the name of the applicant, we may ask you to send us a witness statement explaining the reasons for your request.

For registered marks:

If you want to correct the name or address of the proprietor, for example, because of a clerical error, use form TM26(R) (for rectification), not this one.

If you want to cancel or surrender some of the goods or services, use form TM23 (partial surrender), not this one.
