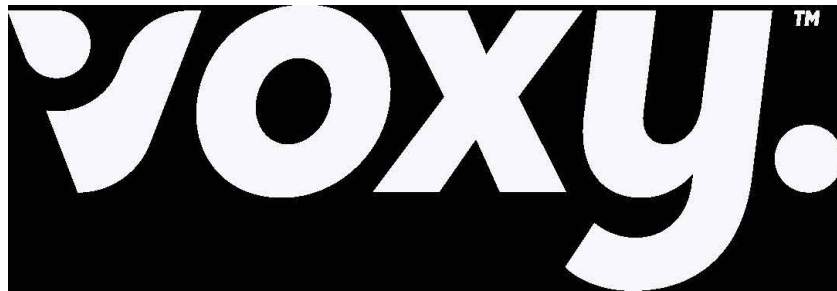

SUPPLEMENTARY DECISION

1. On 14 January 2026, I issued a Substantive Decision in these proceedings which concerned an opposition brought by VO Vehicles Ltd (“the opponent”) against the UK application listed on the cover page of this decision, made by VOXY Ltd (“the applicant”).

2. That decision, in part, concerned a claim brought under section 5(4)(a) of the Trade Marks Act 1994 (“the Act”), and the opponent relied upon 4 earlier signs which were listed in paragraph 6 of the Substantive Decision, as follows:

“6. Under section 5(4)(a), the opponent relies upon the following signs:

- a) The **VO VOXI** sign which it claims to have used in London since 17 August 2012 for the goods and services contained in Annex 3 to this decision.
- b) The **VOXI** sign which it claims to have used in London since 17 August 2012 for the goods and services contained in Annex 4 to this decision.
- c) The following sign which it claims to have used in London since 21 August 2012 for the goods and services contained in Annex 5 to this decision:



- d) The following sign which it claims to have used in London since 21 August 2012 for the goods and services contained in Annex 5 to this decision:



3. The above was correct insofar that, Q1 of section C of the Form TM7 for all 4 earlier signs relied upon stated that they were used from 2012 in London. However, I note the full wording used within the Form was as follows:

VO VOXI sign

“VOXI and VOXI both used from 2012 in London, especially SW London where VOXY Ltd directors live and where Marianne Bailey, designer of VO VOXI lives. After August 2012, it was used internationally. VO VOXI has been used extensively in business plans, presentations, funding applications, emails, business cards, specification documents, company website, domain name www.vovoxi, designs, products. Since 2018, national exhibitions, social media, youtube, COP26, BBC interviews, schools, universities and museums.”

“VOXI has been used in relation to an ebike and sports goods including clothing since 2012 in London, especially SW London where VOXY Ltd directors live and where Marianne Bailey, designer engineer of VO VOXI lives. After August 2012, it was used throughout the UK.”
